## Governor's plan supported

Governor Strickland took a bold step forward when he presented his proposed state budget. Included was a comprehensive plan to improve education in our state.

The Governor has given us a plan that is both daring and creative. He is hard at work trying to keep the promises that he made during the campaign.

Governor Strickland intends to move the state in a new direction. He is putting an end to the negative attacks on public education. Please remember that there are individuals in the legislature who will stand in his way. It is important for us to rally to his support.

Let's look at some of the major points in the plan.

- ☑ Increase per-pupil funding by 3 percent during each of the next two years.
- ☑ Increase the state's share of the education foundation formula by 5.5 percent over the biennium.
- ☑ Increase parity aid (the equalization fund) millage by one full mill and produce an 8 percent increase in this fund to \$521 million.
- ☑ Increase poverty assistance to local districts by 22 percent to a total of \$500 million.
- ☑ Provide state funds for extra costs for special education, transportation and vocational education.
- ☑ Give the Ohio Department of Education authority to penalize charters that do not submit proper data.
- ☑ Place a moratorium on the creation of new charter schools.
- ☑ Reduce the per-pupil aid provided to e-school charters to \$3,000.
- ☑ Establish strong rules in auditing, review and accountability for charters and their sponsors.
- ☑ Discontinue the voucher program except for the original one in Cleveland.

Anyone can see that the proposed budget is filled with important changes that can help our district. But, we will have to take action to gain the advantage. One major negative is that since we are viewed as a *rich district* in Ohio, we will not receive any significant increase in basic funding. The tools are in place for us to repair the damage of the past few years as our school system lost millions of dollars to charters and vouchers.

At their last meeting, the CEA Board of Governors went on record strongly supporting the plan of Governor Strickland.

## Signatures will help Ohio's schools

Our lawmakers are poised to reexamine the school-funding system. A new administration is in place. And recent publicity about the failures of a system supposedly repaired is drawing renewed attention to the matter.

While the CEA supports Gov. Ted Strickland's proposed education budget, it does not solve the school funding problem of over reliance on property taxes. You can do your part to achieve a high quality, fairly funded system by gathering signatures to place a state constitutional amendment on the November ballot. It will:

- √ Realistically calculate the cost of a child's education and require the state to pay more of this cost.
- √ Create an accountability system of public reporting of these expenditures and their results.
- √ Reduce the number and amount of new local property tax levies.
- √ Provide tax relief for senior citizens and homeowners through a cap on increases through inflation.
- √ Protect state funding for school facilities, local governments and higher education

Residents of Ohio can circulate petitions anywhere in the state. Those who sign them must be registered Ohio voters. You cannot sign a petition that you circulate.

You also must have a separate petition for each county where it is being circulated and witness each signature.

### Location rules:

You can circulate a petition in public places, including school board meetings or events (in grocery stores and malls you should secure management's permission).

Teachers and staff may circulate petitions, but not while they are on duty, and not during regular school hours.

## Get out of MySpace.com

It has come to the attention of the attorneys who represent CEA and its members, (Cloppert, Sauter, Latanick and Washburn Law Firm) that a number of teachers, primarily younger teachers, have pages on *Myspace* and/or *Facebook*. In the past nine months, they have had a number of cases with various school districts and the Ohio Department of Education (ODE) in which these websites have been received negatively. It is their advice that if a teacher has a *Myspace* page or *Facebook* page, they take it down immediately. Do not simply log off and allow it to close automatically. If you have one of these pages, go in and manually remove any and all references to yourself. The reasons for this are addressed in the paragraphs below.

First, students can find teachers on *Myspace* and *Facebook*. They can view the website, try to link onto the website as friends and thereby implicate the teacher in a *friendship* or relationship that does not actually exist.

Secondly, there have been various administrators who have stated that only predators and teenagers are on *Myspace*. Various administrators have indicated that they will examine *Myspace* and *Facebook* pages and use this as evidence against teachers in any allegation of inappropriate conduct. Further, the ODE has indicated that teachers having *Myspace* pages and/or *Facebook* pages are acting inappropriately. The ODE does not like teachers having these websites and have used these website pages against teachers in at least two hearings over the past few months. The ODE has insisted that a *Chinese Wall* be drawn between a teacher and student. In other words, no friendships, no close personal relationships, no counseling or other contact with students beyond the classroom. This expressly implicates *Myspace* and *Facebook*.

Accordingly, as action has been taken against teachers' licenses in part based on these pages, it is our advice that if teachers have *Myspace* or *Facebook* pages, they take them down immediately to protect themselves and their jobs.

## TBS needs your support

Want to know more about who's running for public office? Need a place to look for updates to state and federal legislation that affects you (or an avenue for your input)?

Teachers for Better Schools (TBS) is the organization for you. TBS is the political action arm of CEA. It is a separate political action committee that advocates for the benefit of teachers in the political arena.

Among its duties is screening and recommending candidates for various political offices. This endorsement process is highly respected and sought after.

TBS also raises money for political candidates, levy and bond campaigns and other ballot issues affecting Columbus teachers and the school community. And it is there to be your voice in the legislature.

CEA does not use any dues money to promote individual candidates or issues. Instead, CEA members can contribute by payroll deduction.

All it takes is \$1 per pay. It is really very little to give. You won't really miss it in your paycheck. But when you add up all those single dollars, it becomes a potent monetary force. There have been several instances where teachers have taken coursework through an online university with the expectation of earning an advanced degree only to discover too late that the university is not accredited. Columbus Public Schools will not accept any coursework from a non-accredited college or university.
