Complete your trainings

Columbus City Schools is now using Public School Works as an online training tool. All employees are required to log in and complete specific courses. An email from the Public School Works system should have arrived in your inbox with an Internet link. Those who do not complete the training will receive automatic notifications until they meet the requirement. District administrators will receive a report showing who did not complete the training.

Work with your supervisor to schedule time during your work day to complete your required training. There will be no compensation given to employees who complete the training outside work hours. The deadline to complete all required training is Friday, Dec. 19, 2014.

Teacher evaluation details

The Ohio Teacher Evaluation System (OTES) is reality for all of us now. Pertinent details of the CCS adopted format include:

• Half of the teacher rating is based on a summative evaluation of performance, while the entire rating for Licensed Support Professionals (LSPs) will be based on performance. Teachers will develop student growth measures for half of their rating, and

they will have either professional growth or improvement plans, which they will discuss with administrators at their scheduled conferences. Evaluations are at these intervals, depending upon your

Accomplished: One evaluation every third year and the development of a professional growth

- and the development of a professional growth plan; maintenance of an "average" or better rating to continue the three-year cycle
- Skilled: One evaluation every other year and a professional growth plan developed collaboratively with the credentialed evaluator
- **Developing**: Full annual evaluation and improvement plan developed collaboratively with the credentialed evaluator
- Ineffective for the Prior Year: Full annual evaluation and improvement plan developed collaboratively with the credentialed evaluator

Teachers new to CCS will be evaluated by their PAR Consulting Teachers.

Teachers who have moved from an LSP position to a teaching position, or vice versa, will move through the full annual evaluation cycle in their new capacities.

The CCS ILEAD Portal will have up-to-date information regarding the CCS teacher evaluation process.

Walk for research and survival

Breast cancer is second only to skin cancer as the most common cancer among women in the United States. It is the second leading cause of cancer death in women, after lung cancer. The chance of a woman having invasive breast cancer sometime during her life is about 1 in 8. The chance of dying from breast cancer is about 1 in 36. But breast cancer death rates have been going down, probably the result of finding the cancer earlier and better treatment options. There are currently more than 2.9 million breast cancer survivors in the United States.

Let's help more people live by walking to find a cure. When you join the effort, you are helping the American Cancer Society to invest more in research to find, prevent, treat and cure cancer—something it does more of than any other non-governmental organization. Unlike some organizations that support only breast cancer research, the American Cancer Society also funds research to find cures for all types of cancer. It played a role in nearly every major breast cancer research breakthrough in recent history, including establishing mammography as the standard for breast cancer screening, discovering lifesaving treatments, and better understanding factors that can reduce our risk of getting breast cancer. The American Cancer Society also advocates for policy-based solutions that encourage healthy lifestyles and annual screenings, through its nonprofit, nonpartisan advocacy affiliate, the American Cancer Society Cancer Action Network.

Interim and grade card entry

This year, the Office of Accountability and Student Services consulted CEA about the timelines for when our members input interim marks as well as grades for their students. CEA receives numerous calls each year from teachers whose principals have created their own grade entry deadlines.

The entry schedule gives a specific date that teachers are to have their grades and interim marks entered. Administrators are then required to provide grade verification sheets to teachers, and then teachers are to verify the accuracy of their grades/interim entries and correct any errors.
