

## It's up to us, says President Johnson

As CEA members, we have a lot on our plates. We need to elect officials who support educators. We need to stand our ground to support children at every stage of development. We need to keep learning and growing as professionals and be there for each other and our fellow teachers throughout Ohio under all conditions.

"It's going to take all of us doing our part," said CEA President Tracey D. Johnson, delivering her first "State of the Association" address. She told faculty representatives at the opening Legislative Assembly meeting Sept. 11 that times are tough, and teachers are under attack.

Johnson expressed support for the Reynoldsburg Education Association (REA) saying, "This is a political agenda," regarding efforts of the Reynoldsburg board to institute a merit pay system and not address class-size limits. CEA members have attended Reynoldsburg school board meetings en masse in a silent show of solidarity and will continue to support REA during this trying time.



Following a legislative update from the Ohio Education Association, she also called upon delegates for support of CEA's candidate endorsement process through membership in Teachers for Better Schools. It costs only \$1 per pay to voluntarily support this separate, independent political action organization.

Johnson spoke frankly about the State of the Association's efforts to improve morale and preserve teacher rights. "You will see a greater CEA presence in the buildings. Officers and staff have already visited over 30 buildings and will be coming to yours soon," she said.

Though Columbus Schools' report card is mixed, bright spots include improved third-grade reading scores and increases in the Ohio Graduation Test in all areas except math. But more work is ahead, said Johnson. She spoke about the importance of middle school and vocational education for our students and their futures.

Johnson also urged teachers not to let the recent dip in morale affect their work performance. Columbus teachers were recently in a study for their absence rates. "The No. One indicator of student success is a highly-qualified teacher in every classroom every day," Johnson said; and, she urged members to use their leave time wisely. She is working with the district to address the concerns that lead to absenteeism. In the meantime, she said, "We must—we have to—do better. We must help our colleagues understand what the contract says about leave and rally around one another and lift each other up."

During his report, Vice President Phil Hayes touched on multiple topics, including Gainsharing, ABCs, Professional Leave and Fee Waivers. Hayes stressed the importance of the upcoming election, telling the gathered delegates to, "Vote. Vote for your profession. Vote for your family. Vote for your students. Vote for their families. Vote for our future."

The delegates later voted to endorse the Teachers for Better Schools' slate of candidates and issues.

## Vote early starting Sept. 30

Early in-person voting will begin on Sept. 30. To cast an early ballot, visit your county Board of Elections. In Franklin County, you may vote at the Board's offices located at 1700 Morse Road. Statewide hours of service at boards of elections can be found by going to <http://bit.ly/ohvotinghrs>.

If you live in Franklin County, you may request an absentee ballot by mail by visiting <http://vote.franklincountyohio.gov/absentee/> and downloading an application for absent voter's ballot. You should submit your request as soon as possible to ensure there is sufficient time for the Board to mail you a ballot and for you to return it to the Board of Elections by the time the polls close on Nov. 4.

A special election to fill two positions as follows: Governors, Districts 6 (to complete the unexpired term ending in 2015) and Middle School At-Large (three-year term) will take place from Oct. 28-Nov. 10, 2014. The Elections Committee will tabulate votes on Nov. 11. In the event of run-offs, voting will take place from Dec. 2-15, with votes tallied on Dec. 16.
