National Education Association to add Columbus to the roster for their Teacher Leadership Initiative (TLI). The TLI is aligned with her plan to broaden the base and increase the leadership capacity of the CEA membership.

The teacher leader trainees will learn in an interactive format with other expert teachers through in-person meetings and a virtual, collaborative platform. The model brings together three pathways that define ways in which teachers can blaze new paths in education: instructional leadership, policy leadership and association leadership. Additionally, this project will foster leadership in public policy by ensuring that teacher leaders learn and apply the key policy levers that influence educational equity and teaching excellence.

Early voting blocked

On Monday, Sept. 29, the United States Supreme Court

in a 5–4 decision ruled to block early voting in Ohio. Early voting was supposed to begin on Sept. 30 but instead starts on Tuesday, Oct. 7. This is another shameful attempt to restrict voting rights here in Ohio. We must put an end to these vicious attacks on our rights. We must vote! Show Ohio and the



Supreme Court that their efforts to keep citizens from the polls will not succeed. Make sure that not only you vote, but that your friends and family vote also. The power is in the vote. Don't allow Tuesday, Nov. 4, to come and go without your voice being heard.

CEA's election: a special opportunity

CEA is preparing for a special election Oct. 28–Nov. 10 to select its District 6 Governor (to complete the unexpired term ending in 2015) and a Middle School At-Large Governor (three-year term). Involvement in this way is a direct path to making a difference for your Association. Consider declaring your candidacy.

To run for District 6 Governor, you must be a CEA member working in the District 6 area. To run for Middle School At-Large Governor, you must be a middle school teacher. Both positions require that candidates have been members of CEA for the two years immediately preceding this election. Members may declare their candidacy and campaign for either position starting Oct. 6. Campaigning ends on Nov. 10. The Elections Committee will tabulate votes on Nov. 11.
