It's hard to forget the dark day of Sept. 11, 2001. On that day, we ceased to be separate neighborhoods and groups. beginning at 8:46 a.m., the moment when the first plane crashed into the World Trade Center.

### Labor Day: Our Day in Many Ways

A three-day weekend. Cookouts. An extra day to sleep. Ah,

Labor Day. We hope you had a great one and have had a chance to regroup again as we plunge into the new school year. We want to remind you why we take the first Monday in September off every



year. It's easy to forget what Labor Day is really about. First celebrated in 1882 and made a national holiday in 1894, Labor Day honors the American worker and acknowledges the value and dignity of work and its role in American life.

Teachers' unions have assumed an important place in this history. During the past several years, all unions have taken a beating from state courts and legislatures. Right to Work (for less) legislation is breeding across the country, along with propaganda designed to denigrate and weaken our roles. CEA and its sister associations nationwide are now the key to labor's survival. We have what other unions and most other workers lack: an organization of peers in almost every community. Many of our elected officials know this. They are trying to restructure our sector through privatization and control us through standardized testing and other measures while simultaneously limiting democratic oversight.

We won't stand for it. Neither will many of our fellow union members, in and beyond public education. The latest data from the Bureau of Labor Statistics shows union membership at 11.3 percent of the working American public. There are 14.5 million wage and salary workers who belong to unions. We are still here, and we are still working to protect workers' rights.

# While Ohio Legislature Stalls, Another Charter Closes

While more than 50,000 CCS students were anticipating their

first day of the 2015-2016 school year, hundreds of north side Columbus charter school students were blindsided by the last-minute closure of their charter school. The school, FCI Academy, simply posted a note



on its door informing employees, parents and students of its closure after the school's sponsor suspended school operations earlier in the week.

Open for nine years, FCI had received Fs on the most recent available state report card in the standards met, value-added, Annual Measurable Objectives and graduation categories. FCI Academy was more than a half-million dollars in debt and, according to its sponsor, had balanced its budget for the past three years by "continuing to defer debt and borrow from individuals...to make ends meet." In the 2013-2014 school year, FCI received more than \$2.4 million in state funding for CCS students that attended the charter.

Meanwhile, a proposed law that would increase charter school accountability remains bottled up in the Ohio Legislature. House Bill 2 was introduced in January and was approved by the Ohio House and amended by the Senate. When the time came for the Ohio House to approve the changes the Senate had made to the bill, despite having enough support in the House to send it to the governor, House Speaker Cliff Rosenberger, R-Clarksville, refused to allow a vote before the legislature recessed for the summer.

"We need our legislators to move quickly to pass charter school reform legislation," said Ohio Education Association Vice President Scott DiMauro, "and take a serious look at the way Ohio penalizes students in our local districts by the way it funds charters."

It is expected that HB 2 will be sent to a joint conference committee in the fall, where members of the House and Senate will agree on compromises to the legislation before sending it to the governor. Keep reading *The CEA Voice* for updates.
