In the October 2, 2017 CEA Voice, we informed you of



CEA President Tracey D. Johnson's request to meet with the Governor to discuss school funding in the state of Ohio. The initial response from the Governor's office was that they were trying to find a time when he was available

to meet. On September 27, 2017 President Johnson received the following email response:

Ms. Johnson, thank you for your request to meet with the Governor to discuss school funding. While we cannot make it work with his schedule at this time, as Assistant Policy Director who works on Education, I am happy to coordinate a meeting with myself and others who work on school funding. Can you suggest a few times that work for you the week of October 9th? I will see what we can make work for our team.

Although disappointed that there would not be a direct meeting with Governor Kasich, dates and times were sent in order to set up a meeting with Jana Fornario to discuss school funding in Ohio and its impact on Columbus City Schools.

We cannot continue to fund schools in the way that we do in the State of Ohio. It's been twenty years since school funding was deemed unconstitutional in the state of Ohio but we have yet to fix the problem. CEA President Tracey D. Johnson will continue to advocate on behalf of students, our school district and the CEA membership for a fair funding model for our schools. We will keep you informed of the outcome of these meetings.

adopting the calendar. Here are your preferences:

- Teachers report Monday, Aug. 20, 2018
- Winter break, Dec. 24, 2018–Jan. 6, 2019 (inclusive)
- Spring break Apr. 19–26 (inclusive)
- Last day for students May 30, 2019
- Last day for teachers May 31, 2019

Open Enrollment

Open Enrollment for your medical benefits will begin Oct. 10 and end Oct. 31. Everyone must reenroll even if you are not making any changes. Look for emails and information mailed to your home from the CCS Employee Benefits Office. Also, see the Oct. 2 Voice for information on how to enroll.

All benefit-eligible employees must take one of the following actions:

- Reconfirm current elections (even if you only elect the board sponsored life insurance/dental/vision)
- Elect benefits or make changes (add or delete dependents, update beneficiary information, etc.)
- Waive Coverage

Employee Self Service (ESS) will be used for the 2018 enrollment process. Benefit choices made during Open Enrollment are effective January 1, 2018. Please make sure that you are able to log on to ESS prior to the start of Open Enrollment. ESS will not be available for benefits review (if newly hired) or enrollment until October 10, 2017.

Thinking About Retiring?

Staff members planning on retiring at some point in the 2017-18 school year can be exempted from the Ohio Teacher Evaluation System (OTES). Ohio Substitute House Bill 365 states: "A board of education may elect to not conduct an evaluation of a teacher who has submitted notice of retirement and that notice has been accepted by the board not later than December 1 in the school year in which the evaluation is otherwise scheduled to be conducted."

Members who would like to exercise this option must submit their notice of retirement by November 3, 2017, to Human Resources. Go to <u>http://bit.ly/ccsretireresign</u> to download a copy of the retirement/resignation notification form, or feel free to draft your own. Your Association recommends hand delivering your notice of retirement and obtaining a time-stamped copy. Open Computer Labs for SLO Revisions

For CEA members evaluated on the teacher rubric should have submitted two student learning objectives (SLOs_ for the student growth measure requirement of your evaluation. Initial submission of student learning objectives (SLOs) was due on September 29, 2107. For members needing to revise their SLO(s), consider visiting Huy/A.G. Bell ES or Berwick K-8 on Wednesday, October 18 from 4:30-6:30 PM. Computer labs at both buildings will be available to members to access and work on revisions. Members of the joint evaluation team will be in attendance to assist with any questions. To reserve your space, sign up for a SLO revision work session on CiMS.

LPDC Training Sessions

The Columbus Local Professional Development Committee (LPDC) will be hosting face-to-face training sessions for becoming a CIMS Facilitator. If you were trained in person last school year, you do not need to attend a face-to-face session again this year, and will only need to complete a "refresher" module and the updated Facilitator Agreement (check your email for the links).

For those who are new, CIMS is the district's system for tracking participation in professional development activities, especially with regard to earning CEUs. In order to be a "provider" of professional development and have individuals receive CEUs (e.g., PD Days, BLT sessions, etc.), you MUST attend a face-to-face training to learn all of the important steps to enter PD Activities into CIMS and track attendance.

The LPDC will also be hosting support sessions for those needing assistance in creating an Individual Professional Development Plan (IPDP). All educators with 5-year Professional Licenses in Ohio must have an approved IPDP on file in order to earn credits toward the renewal of that license.

You can find upcoming facilitator training dates and IPDP support sessions in CIMS by searching for "CiMS Facilitator Training 2017-18" or "IPDP Support Session 2017-18".
