CEA members fight EdChoice Voucher Program

The Ohio Legislature convened a conference committee for

the purpose of reconciling differences between HB 9 and SB 9. Both bills propose to fix the expansion of the EdChoice Voucher

Program. The Ohio Education Association and the Columbus Education Association strongly support SB 89 as passed by the Ohio House.

SB 89 would change EdChoice voucher eligibility criteria from a performance-based award based on a school's score on the flawed state report card to an income-based system. The program would be directly funded by the state instead of deductions from school districts. SB 89 would dissolve academic distress commissions in Lorain, Youngstown, and East Cleveland. The bill would also establish a study committee to look at state testing and report cards and perform cost studies related to school funding.

The Conference Committee held a total of ten hearings beginning Feb. 11 and concluding on Thursday, Feb. 20. Multiple CEA members testified in person in support of SB 89 or provided written testimony. Even more CEA members attended the hearings in support of the members who were testifying. Here are excerpts of their testimony:

"How could we create a report card for our legislators? Would legislators who were the primary sponsor of bills that became a law get a higher score than a legislator who was a cosponsor? If a legislator writes more bills than another one, would one legislator be graded higher than another? Would we look at the legislative achievement gap between Democrats and Republicans and attempt to address it? Would we take resources from an over-performing party or chamber and give it to an under-performing party or chamber? - Phil Hayes (CEA Office)

"To say that we need to fund alternatives to public schools because they are failing is like telling a parent that they should give up custody of their child because their child has a medical condition. The situation deserves more resources and care, not more punishment. A 'stick' does not scare away situations that require systemic changes." - Sean Powers (School Counselors)

"Teaching is one of my greatest joys in life. I love coming to school every day and seeing the bright faces of my students. That's why it breaks my heart that my kids come to school and try to learn in a building in disrepair. The walls of our school are disintegrating. And the heartbreaking thing is that my kids are aware of it." -Ben Alexander (Eastmoor Academy HS)

"Vouchers disproportionately go to students that do not have special needs. These general education students then attend schools that have a significantly lower rate of students with special needs than do their traditional public school contemporaries. The transfer of students as directed by their families is a God-given right. The transfer of funds, however, requires the traditional public school to do more with less." -Kevin Daberkow (Southwood ES)

"\$28,800,00 was taken from my students in one year. My students are losing tens of millions every year to schools where children are falling further behind. I've watched students from those schools transfer to Mifflin MS, staggered at the expectations I hold for my students. Correcting the missteps takes time and money, resources that SB 89 will allow us to keep. So let us

do what is best for our students." -Joe Decker (Mifflin MS)

"The state report card from my school does not accurately share the narrative of my students and it is being used as an excuse to take needed funds away from Columbus City Schools. Public schools deserve adequate funding to ensure the utmost success for those who fill their classrooms each day. I urge you to move away from paying for some students' private school tuition by deducting that money from state funding to my district and other districts across Ohio." - Chris Williams (Colerain ES)

"Public schools educate all students. Sometimes a student comes to our school right before the test, and it is counted on our state report card, then leaves again right after the test. This is the same state report card that determines whether the students in our neighborhood qualify for a voucher. If you spent all the money that you have been giving to vouchers and charter schools and gave it back to the public schools, we could fix a lot of the problems that we have." -Larry Carey (Trevitt ES)

2020 Primary Early Voting Has Begun

In 2019, state legislators moved Ohio's primary from the month of May to the month of March. Ohio's 2020 Primary Election will be held on Tuesday, Mar. 17. This year's election falls on St. Patrick's Day. Due to the extremely gerrymandered electoral districts in our state, often times the Spring Primary Election decides the outcome of the General Election in November. Even though the Primary Election is Mar. 17, you can vote early in-person at your county Board of Elections. In Franklin County, you may vote at the Franklin County Board of Elections, 1700 Morse Rd. Advance hours are:

- Weekdays beginning Wednesday, Feb 19,–Friday, Mar. 6, from 8 a.m.–5 p.m.
- Saturday, Mar. 7, 8 a.m.–4 p.m.
- Monday, Mar. 9–Friday, Mar. 13, 8 a.m.–7 p.m.
- Saturday, Mar. 14, 8 a.m.—4 p.m.
- Sunday, Mar. 15, 1–5 p.m.
- Monday, Mar. 16, 8 a.m.–2 p.m.

Article 211: Alternative Interview Panel Deadline Approaches

The *Master Agreement* defines the interview panel as the principal, the Senior Faculty Representative, one elected member of the Association Building Council and two parents/members of the school community. However, as noted in the 211 Manual, buildings may convene an alternately constructed panel.
