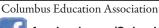

# Know Your Governor: Carla Davis

Carla Davis isn't one to sit on the sidelines. When the staff

and administrator in her building were increasingly at odds, she stepped in. She ran for CEA Faculty Representative and won. Then she got to work, drawing in the ABC and her colleagues and team building. Now, the staff and the principal at Forest Park ES work better together. Davis, a Math CCIT at Forest Park ES, continued her CEA service as FR for an-



other year and as alternate for four subsequent years.

When she saw that teaching rights were threatened, Davis joined the fight that defeated Senate Bill 5, working the phone bank and canvassing. She helped register people to vote and promoted pro-education candidates, starting with Obama in 2008.

Last year, the 17-year teaching veteran, whose two children attend Columbus City Schools, ran for district governor and now represents District 2. Her husband, Randy—a union member himself for many years, through his job at AT&T—is behind her all the way.

Davis says she finds power in solidarity. "When we would go to the District LA, I would meet a lot of people. I like talking to people and seeing what's working and what we could change in our building.

It's also about the contract. "I came from a non-union state, Mississippi. Everything the administrators told us to do, we did," she said. She often talks with colleagues about the importance of knowing their rights.

"A lot of times you have the contract, but you don't really look at it," she said. Davis encourages fellow CEA members to look in the contract book and become familiar with the hardwon rights they must protect. "Know what's grievable," she said.

### Take the PBIS survey

The Ohio Department of Education has adopted the use of a non-aversive effective behavioral system required for use by all school districts in the State of Ohio. This adoption goes into effect in the 2013–2014 school year. CCS has adopted the Positive Behavioral Intervention and Supports (PBIS) approach to be used to create a learning environment that promotes the use of evidence- based behavioral interventions.

The district has asked CEA to conduct a PBIS readiness survey. The purpose of the survey is to assist schools in determining the effectiveness of existing supports and structures used to implement the PBIS process. It will also influence PBIS-based decisions made by the Building Leadership Team (BLT) at your school. Every bargaining unit member should participate in this survey because the data will be used to improve the climate at your school.

An email containing the link to the survey was sent to members' non-CCS email addresses on Friday, Sept. 7. The survey will close on Sunday, Sept. 15, at 11:59 p.m. If you did not get the email message, or if CEA does not have your current non-CCS email address, send it to tellcea@ceaohio.org to participate in the survey. You will be able to access this survey from home or from work.

## Don't leave your colleagues behind

What if you became ill and had to make the choice of going to work or losing everything?

Each year that's exactly what happens to some of your colleagues. They experience devastating illnesses and injuries that require long recovery periods. Fortunately, there is a way we can all help. It's called catastrophic leave, and we need your donations now.

When a member of our bargaining unit has exhausted all of his or her sick and personal days as a result of a catastrophic illness or injury of a temporary nature, he or she becomes eligible for catastrophic leave. After their catastrophic leave application is approved, he or she is able to accept additional sick leave days that have been donated by other bargaining unit members.

Take the time to fill out a sick leave form available at your workplace. To donate to a specific person, enter your name at the top of the CCS Report of Employee Absence form. In the "Comments" section add the words, Catastrophic Sick Leave Donation. Write in the name of the intended recipient. If you are going to make a general sick leave donation, fill out the form with Catastrophic Sick Leave Donation in the "Comments" section. Be sure that you and your principal or supervisor signs the form.
