A victory

The first step was a success. With pressure from OEA, the Ohio Senate unanimously passed SB 229 on Dec. 4. If the House approves it as is, and if the governor signs it, the bill will take effect on July 1, 2014, to help make Ohio's teacher evaluation system more effective, fair and efficient.

Let's keep it up! Legislators in the House need to hear our collective voice on SB 229. To urge your representative to vote to send the bill to the governor, go to <http://cap-wiz.com/nea/oh/mlm/signup/>. Included in the SB 229 are the following provisions:

- ♦ Academic growth factor: The value-added academic growth factor percentage required on teacher evaluations is lowered to 35 percent from the current 50 percent. School districts can add an additional 15 percent of value-added or substitute formal observations, reviews or other tools.
- ♦ Frequency of evaluations: School boards will be authorized to reduce the frequency of evaluations for teachers who receive one of the top two ratings. Teachers who receive the rating of "Accomplished" could be evaluated every three years, and teachers who receive a rating of "Skilled" could be evaluated every other year.

This is BIG. We want teachers rated fairly. Evaluations should not be based on tests that were intended to help teachers improve classroom instruction. Tools, such as value-added, were never designed to be valid and reliable for high-stakes decisions like teacher evaluations.

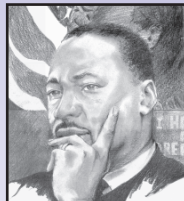
Tickets are going fast...

Columbus City Schools Assessment Leaders Initiative

Research has shown that teachers spend from a quarter to a third of their professional time on assessment-related activities. Almost all do so without the benefit of having learned the principles of sound assessment (Stiggins, 1999).

Columbus City Schools is supporting teacher effectiveness to have the largest impact on student learning. CCS has developed an 18-month teacher leadership initiative, Assessment Leaders, to cultivate understanding of assessment literacy and other initiatives. Assessment Leaders are teachers who will be jointly selected by the Building Principal and Senior Faculty Representative with each school



identifying one Assessment Leader for each 10 classroom teachers on the staff. Additionally, Assessment Leaders will participate in professional development tailored to preparing them to review and approve Student Learning Objectives for the teachers in their respective buildings.

The professional development will include in-depth training on the following topics:

- Assessment Literacy
- Student Learning Objectives
- Student Growth Measures
- Formative Instructional Practices

Assessment Leaders will receive two semester hours of graduate credit this year as a part of their participation and learning through this initiative.
