Professionals need credentials

"My barber has to prove that he is prepared to be a barber and earn a license before he is allowed to cut my hair, yet some states and districts allow individuals to be in charge of classrooms and student learning before proving that they should be there. Every student deserves to have a 'profession-ready' teacher."

The NEA—and CEA—believe that all teachers should be "profession-ready" from their first day of being responsible for student learning. This means that, before becoming a teacherof-record, teacher candidates must demonstrate the skills and knowledge needed for effective classroom practice. Yes, our governor, John Kasich wants to "deregulate" our schools. In a speech to the annual Ohio Newspaper Association Convention held in Columbus, Kasich said, "I would like to figure out a way to keep people from having to jump through all these legal hoops out there in our local schools."

"Some teachers feel overburdened by the way in which testing is done," Kasich said. "Schools feel there are too many certifications and too many rules. We need to figure out how we can bring more common sense to the rules and more trust to the people in the local communities who are running our schools."

But what exactly does this mean? It's not entirely clear, but Kasich did suggest reducing licensing requirements related to the Third-Grade Reading Guarantee. We know that he also has talked about removing state rules for class sizes and personnel and leaving those up to local education boards. The news media reported that he also wants the business community to be more involved in local schools. There is speculation he could try to relax licensing requirements so that business professionals may come into classrooms and teach, or establish a connection between the state and the business community so business leaders could influence curriculum.

The 2013–2014 annual staff survey will be administered online. An email containing the link to the survey was sent to members' non-CCS email addresses on Friday, Feb. 14. The survey will close on Sunday, Mar. 2, at 11:59 p.m. If you did not get the email message, or if CEA does not have your current non-CCS email address, please send it to tellcea@ceaohio.org to participate in the survey. You will be able to access this survey from home or from work.

The survey results for each school/building will be published on CEA's website, so you can make informed decisions during the 211 process this spring. Additionally, a hard-copy of the open-ended responses will be provided to the respective Senior FR for each school/building.

When you complete the survey, you will automatically be entered into a drawing to win an iPad Air with Retina Display, 3G capability and 16 Gb of memory or one of 20 gas cards worth \$25 each.

Get paid to assess new teachers

Want to help your fellow teachers? The Ohio Department of Education needs teachers to use their professional skills to assess beginning teachers. You can get paid to use your expertise. The RESA is a performance-based assessment that an Ohio beginning teacher, known as a resident educator, must successfully pass. The assessment calls for these novice teachers to demonstrate their ability to design and implement instruction that: engages students in complex thinking and uses formative and summative assessments to inform their teaching practices. Resident educators must successfully pass the RESA to qualify for a five-year professional license.

Assessors will review and score RESA submissions by teachers. Each will be assigned based on the need for particular skills and knowledge to score each task. Assessors will be allowed to work for as much time as they have available, up to 30 hours per week.

Each assessor applicant must:

- > Have a minimum of five years teaching experience
- ⇒ Complete online training and pass a certification test before scoring assessments
- ⇒ Agree not to conduct assessments of teachers he or she knows
- ⇒ Be familiar with performance-based assessments or have experience scoring them


