She held numerous other positions along the way, including chair of CEA's Legislative Committee and served as secretary and then president of the TBS.

Carol enjoyed travel throughout the United States, Europe and Latin America. She had a marvelous sense of humor and enjoyed collecting pigs. She also enjoyed studying political history. She was a strong advocate of the middle class and was our resident expert in insurance matters.

Carol's memory will remain an inspiration for all of us. CEA is a better organization because she was here.

# STRS and preschool teachers

There is an important change coming for bargaining unit members who positions have been determined to be of mutual interest by STRS and SERS. For example, the Ohio STRS and SERS have determined that pre-school teachers will pay into SERS instead of STRS effective July 1, 2014. You should be receiving information about this from the district. It is the employer's responsibility to provide you with this information. It is important for you to check to make sure that the district has your correct personal information and teaching assignment so that your investment is going into the right retirement system.

## **Budget Year II: Education and taxes**

Gov. John Kasich has a lot of items brewing for the second half of the budget biennium. His Mid-Biennium Budget Review (MBR), House Bill 472, outlines policy and funding priorities for the second year of the state budget. In the past, the review has been split into multiple bills, some sent for deliberation to the House and others to the Senate. So we are uncertain how the major components will be addressed. So keep reading *The CEA Voice*.

The governor is proposing many changes affecting public schools, and future bills may include such items as graduation requirements and teacher evaluations. Here are other major items we will be watching:

Dropout Prevention: Nearly 24,000 students drop out each year. A bill could require new state and local strategies to identify at-risk students and serve them more effectively, including with career advising, new academic pathways and remediation in math and English.

Dropout Recovery: As many as one million Ohio adults lack a high school diploma. A proposal may create incentives for adults age 22 and older to return for their diplomas and job training.

Encouraging Mentorship: A new program would use \$10 million from casino license fees to provide matching grants in support of efforts to mentor low-income students. New state guidelines could provide matching grants for programs that sponsor career advising and mentoring.

Expanding Access to Vocational Education: Kasich proposed making technical and vocational education available to students beginning in the seventh grade to give them a jump-start toward a career path. Districts would be allowed to opt out.

The governor also proposed strengthening provisions for closing down poorly performing charter schools serving dropouts.

In the coming weeks, the state senate and house will weigh in on these and other proposals, collect testimony and set priorities.
