# Step up and represent your peers

Faculty Representative elections are coming up Apr. 30–May 29. By serving in this capacity, you help your fellow Association members make their voices heard.

FRs serve as building-level leaders within their schools/ units. FRs represent their members by distributing Association materials, conducting CEA elections, running multiple charitable campaigns throughout the year, attending CEA District and Legislative Assembly meetings and serving on building-level committees. As an FR, you keep your building informed of important Association matters.

We elect FRs to their two-year terms during the spring of odd-numbered years. Each school/unit elects one FR and one Alternate FR for every 20 school/unit members, or fraction thereof. Elections are conducted by secret ballot. A person on the ballot cannot participate in the election administration.

If you have more than one FR, the senior FR shall be the one with the most continuous service in that school/unit. When continuous service is tied, the SrFR shall be the FR who receives the majority of votes.

Let your elections chairperson know if you are interested in running. Ask other FRs to share with you why they love CEA service. When you get the slate of candidates, be sure to vote. If you have any questions, call Michelle Mays, Elections Co-Chairperson, at the CEA office at 253-4731.

### Help fix the broken testing law

Recently, the Senate Health, Education, Labor and Pension Committee voted unanimously to send the *Every Child Achieves Act* of 2015 to the floor of the Senate. The bill is a reauthorization of the Elementary and Secondary Education Act (ESEA), and would replace the infamous *No Child Left Behind* authorization of 2002

"We applaud Senators Alexander and Murray, along with all the members of the committee, for listening to educators and leading the improvements made to the bill in committee over the course of the past week," said NEA President Lily Eskelsen Garcia. "We still have work to do to ensure equity and opportunity for all students."

Key amendments adopted this week to help close opportunity gaps and give students more classroom learning time include:

- Requiring all schools to use multiple measures to evaluate progress (rather than just test scores), including at least one indicator of student or school supports (like access to nurses or guidance counselors)
- Strengthening the pilot program for state-designed assessments to broaden participation and encourage assessments driven by teaching and learning—not by accountability alone
- Ensuring the rights of parents and guardians to have their children opt out of statewide academic assessments without detriment to schools or the children themselves

Recently, the OEA Congressional Contact Team for District 3 met with Congresswoman Joyce Beatty's District Director Matt Koppitch to discuss the importance of getting ESEA right. We thank Congresswoman Beatty for her continued support of CEA and public education in general. CEA was represented by Tracey Johnson (CEA President), Phil Hayes (CEA Vice President), Karen Andermills (CEA Legislative Coordinator), Paula Garfield (CEA Member) and Robin Jeffries (NEA Director #6).

The Senate is expected to debate the *Every Child Achieves Act* in the next few weeks. Floor fights will be intense to preserve our gains and further strengthen the bill. ## Budget moving to Senate

Earlier this month, the Ohio House Finance and Appropriations Committee adopted a substitute bill to House Bill 64, the governor's two-year proposed budget. On Apr. 20, the committee made amendments and sent the bill to the House floor on a 21–11 party-line vote.

The committee voted to remove language that would have stripped full-time higher education faculty members of their collective bargaining rights and prevented unionized charter school teachers from membership in STRS.

Additionally, the committee voted to include additional monies for school districts so that no schools will experience a loss in state funding.

The full House was expected to vote on the bill on Wednesday, sending the proposed legislation to the Senate for deliberation. Go to <a href="http://www.ohea.org/legislative-watch">http://www.ohea.org/legislative-watch</a> for the latest update on the state budget.

### Know Your Contract: Verbal Abuse

Teachers are professionals and should be treated in a professional manner. Direct verbal criticism of a teacher in front of students or parents reduces the teacher's ability to maintain an orderly teaching environment. Administrators do occasionally need to redirect staff. However, such direction should be respectful and should NOT be given in front of students, parents or other staff members

Section 404.06 of our *Master Agreement* details your rights when criticism has been lodged inappropriately. If criticism occurs in an inappropriate setting, the teacher may request a conference with the administrator to discuss the incident. If the administrator repeats this inappropriate behavior, the teacher is entitled to a second meeting and can file a grievance. During these meetings, CEA members are always entitled to CEA representation. Administrators, too, may request Board of Education representation.

If you have been subjected to verbal abuse, know that you do not have to put up with it. Call CEA to file a grievance.
