



#### HS and MS Teacher Lunches are One Period Long

CEA members in some high schools have been contacting us about a rumor that their lunch period will be shortened next year. It appears that some principals are telling HS teachers that their lunch during the 2016–2017 school year will only be a half-hour long instead of a full period. Your Association has negotiated language that protects the length of HS and MS teacher lunches.

In effect since the 2009–2010 school year, the Memorandum of Agreement on the Eight-Period Day in High Schools and Middle Schools (page 173–174 in the *Master Agreement*) specifies:

- Middle and high schools will operate on an eightperiod day
- HS and MS school teachers will have a one-period lunch as is normal
- Any changes in this agreed-to-schedule need approval from the Reform Panel

Changes to the length of a teacher's lunch at high or middle school currently on an eight-period day cannot be unilaterally implemented by your principal. Any high or middle school that is currently on an eight-period day that wants to change the length of teacher lunches for next school year must get approval from the Reform Panel prior to the end of this school year. - As of January, 75 percent of CCS seniors had submitted at least one application for postsecondary enrollment. Additionally, 89 percent of high school seniors with a 2.0 or higher cumulative GPA had participated in at least two one-on-one advising sessions with their IKIC advisor in preparation for college.
- Lastly, working hand-in-hand with middle school

teachers and counselors, IKIC AmeriCorps College Guides worked with nearly nine thousand CCS students to explore options for life after high school through Naviance.

While these accomplishments are meaningful steps towards achieving our BOLD GOALS by 2020, significant work still lies ahead. # Paying for College

Your high school senior may be eligible to receive a CEA scholarship. The deadline for submitting applications for CEA scholarships is Friday, Apr. 22, 5 p.m. Two of the scholarships available are the \$1,500 Christa McAuliffe Scholarship, awarded to a student pursuing a degree in education, and the \$1,000 CEA General Scholarship. Both are renewable for up to four years at a reduced level from the first-year award. Also, one-year scholarships are awarded by CEA-R and the Rhonda Johnson Scholarship Fund. A senior at South HS will be awarded the John E. Grossman Memorial Scholarship. Applicants must be children of CEA or CEA-R members. Applicants must be graduating high school seniors or students already enrolled in an undergraduate program in a college or university.

The Christa McAuliffe Memorial Scholarship is granted each year to a student majoring in education unless no applicants indicate they are majoring in education. This scholarship will be one and one half times the amount of any other scholarships awarded.

Applicants must have a cumulative grade point average (GPA) of 2.5 or above, which must be verified by an official high school or university transcript.

- In addition, applicants must:
- Be full-time students while enrolled in college.
- Include a copy of the Student Aid Report form FAFSA.
- Indicate all financial aid (other than student loans) they expect to receive.

Along with each application, applicants must provide:

- A statement of his/her personal philosophy and goals.
- A personal reference from someone other than a family member.
- An academic reference.
- A verification of GPA by official transcript.

- □ The CEA Book Drive has ended, but you can still donate new books appropriate for children reading on the pre-primer through third-grade reading level. Your FR has a suggested book list. Donate three books or more and you will be eligible to receive one of five randomly drawn \$100 VISA gift cards. Give books to your FR or building campaign chairperson, and ask for an entry form for every three books you donate. Completed forms go to Teri Mullins at the CEA office (Rt. #1) no later than Friday, Mar. 4.
- □ The district's UNCF campaign ended Feb. 26. We want to thank everyone who gave. Fifty percent of every dollar we raise is designated for scholarships for Columbus City School students. If you have not returned your completed pledge card to your FR, please do so as soon as possible.
- □ The deadline to apply for a continuing contract for the 2016–2017 school year is Mar. 5. CEA recommends you hand deliver to Human Resources and request a time-stamped receipt.
- □ Ballots for the 2016 CEA Election arrive in buildings on Tuesday, Mar. 1. Campaigning is under way through Mar. 14. Candidates are running for President and High School Governor At-Large, NEA Local Delegates and NEA State At-Large Delegates. Members will vote from Mar. 1–14, with votes tabulated on Mar. 15. SrFRs need to have ballots ready for pick-up first thing in the morning on Tuesday, Mar. 15. For questions, contact CEA Elections Committee Chair Neil Moore at (614) 264-2188.
- By now, each building should now have an Article 211 Interview Panel composed of its administrator, Senior FR an elected ABC member and two community members.
