## Ohio's State Tests (AIR)–Spring Administration

The CCS windows for Ohio's State Tests in English Lan-

guage Arts, Mathematics, Science and Social Studies are quickly approaching.



American Institutes for Research (AIR), the vendor for Science and Social Studies in the 2014–15 school year, is now the vendor for all subject areas in the State of Ohio. CCS provided the opportunity for individual schools to choose their testing format (paper and/or online). The following are the Columbus City Schools' testing windows for spring 2016:

### English Language Arts (ELA)

Paper Testing: Tuesday, Apr. 5–Monday, Apr. 18 Online Testing: Tuesday, Apr. 5–Monday, Apr. 25

### Math, Science, and Social Studies

Paper Testing: Monday, Apr. 25–Friday, May 6 Online Testing: Monday, Apr. 25–Friday, May 13

There are several important things to remember if you are administering state tests:

- DO read your *Directions for Administration Manual* prior to your testing session.
- DO make sure that you are aware of the allotted time for each of the state tests. (This varies depending on the test.)
- DO make sure that IEPs are updated and reflect the correct accommodations for students prior to testing.
- DO review the information from your spring testing training provided by your principal and School Testing Facilitator prior to testing.
- DON'T use your cell phone during testing. (The need for technical assistance for an online test is the only reason a cell phone should be used.)

We know that you have prepared our students for success and are thankful that the State of Ohio has eliminated the Performance Based Assessment (PBA); thereby, reducing testing by over one half. ### **Roster Verification**

Along with warmer weather and spring flowers blooming, Roster Verification season is fast approaching. Roster Verification, also referred to as "Linkage," is the process that allows teachers to verify the student rosters that will be connected to them when value-added teacher level reports are created. Value-added teacher level reports highlight a

teacher's level of effectiveness based on the growth or progress of their students. Teachers can use these reports to reflect on their teaching practices and determine how effective they have been toward improving students' academic growth. At this time, these reports are not a part of the student growth measure in the Ohio Teacher Evaluation System (OTES) due to the change from OAA and PARCC testing to AIR testing, but they will be in the future.

All licensed/certified teachers planning and/or providing instruction for students in the following areas are required to participate in the roster verification process and will receive teacher-level value-added reports for the 2015–2016 school year:

- 4th grade ELA and Math
- 5th grade ELA, Math and Science
- 6th grade ELA, Math and Social Studies
- 7th grade ELA and Math
- 8th grade ELA, Math and Science
- Integrated Math I and Integrated Math II
- English I (English 9) and English II (English 10)
- Biology
- American History

There are three phases to the roster verification process: School Set Up, Teacher Roster Verification and Principal Review and Approval. After the principal and the school support team finish the School Set Up phase, verifying which teachers teach which classes, the teacher will have the opportunity to complete the Roster Verification Phase. Teachers must verify what subjects they taught, which students they taught, which months they taught them and what percent of time they were responsible for their instruction. These are the rosters that are submitted for the teacher level value-added reports; therefore, it is very important that teachers are given the opportunity to confirm that the students connected to them are accurate. If you are a teacher who instructs one of the courses listed above, you should be completing the roster verification process during the Apr. 27-May 17 window.





### A Tribute To Our Retirees



### Sick Leave: Follow the Rules

CEA has been representing a number of members whose

leave has been questioned. We do not want our members to put themselves at risk for disciplinary action (or termination) because they



failed to follow the rules. Review Article 701 of the contract. Help us stay true to our negotiated agreement by following these rules:

- If you are to be absent for one full school day or more, you must report your absence to the principal or to the district's Substitute Employee Management System at least 1.5 hours prior to your normal report time.
- If you are absent on a Monday through Thursday, you must inform your principal or school clerk before 2 p.m. on the day before you wish to return.

- Sick leave is for personal illness, absence due to illness in the immediate family or for death in the immediate family of the teacher. When you return to work, you must complete an absence form within three days. It is your responsibility to make sure this gets done.
- Absences longer than ten continuous school days require an Application for Leave. Before you return from leave, you must have a doctor's statement and district pre-approval.

If your supervisor has a concern about your use of sick leave, he or she can hold a conference with you at your school. You may be represented by your Senior Faculty Representative or a designee of the Association. Following this conference, if your administrator continues to have concerns about your use of sick leave, you may be called for a pre-disciplinary hearing.

We bargained sick leave use rules for our members in good faith. It is up to us to make sure we live up to the rules.
