Issue 57: Our Members, Our Students

The Columbus City School District has a levy issue on the ballot for the upcoming November Election. It is Issue 57, a 6.92 mills Bond Issue and Tax Levy. Issue 57 will generate 5.58 mills for Operating and Staffing, 84 mills for Deferred Maintenance and .5 mills for Permanent Improvement (this was incorrectly printed in *The CEA Voice* on September 19).

Issue 57 is about preparing, protecting and providing for our students. Issue 57 will place more nurse practitioners and behavior health specialists in our buildings to assist us in meeting the social, emotional and mental needs of our students. It will transform career-tech by increasing the amount of career-tech courses offered to juniors and seniors. All seventh grade students will be able to take advanced computer engineering courses. Issue 57 will expand early childhood education, support for special education students, reduce the adult-to-student ratio and enhance student safety. In order for all of these things and more to become our reality, we need your help. Everyone must do their part to ensure Issue 57 passes. We can do the following:

- Make sure we are registered to vote and go to the polls and vote.
- Make sure family and friends are registered and encourage them to vote.
- Share our positive stories. There are so many great things happening in CCS and who better to tell our story than us.
- Volunteer to canvas, phone bank and do lit drops.
- Donate to the Successful Schools Committee.

We are asking that every CEA member donate \$20 to the Successful Schools Committee. In the past we have asked members to donate a lot more but the CEA Officers and Governors decided to be more realistic. You can always give more if you choose. President Tracey D. Johnson is leading the way and has already donated \$200. If all 4,100 CEA members donate just \$20, we can generate \$82,000 to assist with mailings and print and television ads. Open Enrollment - It's Required

During Open Enrollment (Oct. 6–30), all benefiteligible bargaining unit members *must* do one of the following:

- 1. Reconfirm any current benefit elections.
- 2. Elect or make changes to benefits (add or delete dependents, update beneficiary information, etc.).
- 3. Waive coverage.

Employee Self Service (ESS) will be used for the 2017 enrollment process. Make sure you are able to log on to ESS **PRIOR** to the start of Open Enrollment. Benefit choices made during Open Enrollment will be effective Jan. 1, 2017.

To participate in Open Enrollment, benefits-eligible bargaining unit members can:

- 1. Meet in person with a Benefits Counselor. See your supervisor for more information as these are still being scheduled. The final schedule will be available on the Open Enrollment website after Oct. 1. Please be advised that counselors will not be available to meet with every employee at every work location.
- 2. Meet in person with a Benefits Counselor at the Kingswood Data Center. To register for an appointment, go to http://bit.ly/ccsbenefits2017 and use your CCS email username and password to sign in. This link is only accessible from a district computer. The following dates/times are available: Oct. 12, 14, 17, 25 and 27 from 3–6 p.m.
- 3. Meet online with a Benefits Counselor in a CoBrowsing session. To schedule your call center enrollment meeting ahead of time, visit *iSelectSchedule.com* to sign up. Enter Enrollment Number 61436, and follow the instructions on screen. Scheduled Call Center appointments will be available from 11 a.m. to 7 p.m. Monday through Friday. You must be able to access ESS and join the Benefits Counselor on a computer with the ability to print your confirmation statement. You will be responsible for entering your information into ESS with Counselor assistance.
- 4. Use ESS to confirm, change or waive your benefit elections. No meeting with a Benefits Counselor is required if you do not wish to elect new or change current Voluntary Benefits.

CCS must report health care coverage information for its employees and their dependents to the federal government. Please verify that the Social Security numbers entered into ESS for you and your dependents are correct. You must meet with a Benefits Counselor in person or online to make or change elections for your Voluntary Benefits which include: Life Insurance with Long Term Care Benefits, Short Term Disability, Critical Illness Insurance, Accident Insurance and Pet Insurance.

If you wish to terminate any of your Voluntary Benefits, you must:

- Complete a Supplemental Insurance Termination form (included in the Benefits Open Enrollment Guide materials).
- 2. Submit the completed form to the Benefits Department. Your Association recommends hand-delivering the form and getting a time-stamped copy as your receipt.
- 3. Contact your Voluntary Benefits provider to notify them of your cancellation.

CEA Office: Involvement from Within

One of the best ways to support CEA is by running for Association office. When you serve the Association in this way, you become part of the process. You bring forward your peers' concerns and you help find solutions. You have a voice in union affairs. You also help improve the teaching profession. When you hold an office, you have the opportunity to attend briefings, vote on important issues and represent CEA on the state and national levels.

A special 2016 Fall Election will be held to fill the following two positions: Middle School Governor At-Large #1 (to complete the unexpired term ending in 2017) and Middle School Governor At-Large #2 (full three-year term).

Members may declare their candidacy from Oct. 10 to Oct. 21. Campaigning begins Oct. 10 and ends Nov. 15. Voting begins Nov. 1 and ends Nov. 15. Votes will be tallied Nov. 16. In the event of a fall run-off election, campaigning will begin Nov. 17 and end Dec. 13. Voting begins Nov. 29 and ends Dec. 13; votes will be tallied Dec. 14.

Special Note

Have a college senior? Scholarships are available from the CEA Member Scholarship Fund. Each scholarship provides \$1,250 in tuition assistance per awardee. Eligible CEA members must have taught in CCS for the past four years. Your student must have a minimum 2.0 GPA to apply. The deadline to receive the application is 4:30 p.m., Friday, Oct. 21.
