## MLK Dinner Will Feature Michael Eric Dyson

The Columbus Education Association is proud to announce that the keynote speaker for CEA's 38th Annual Dr. Martin Luther King, Jr. Awards Dinner will be Michael Eric Dyson. Dyson is one of the group of "new intellectuals" whose work addresses issues of race and culture across such diverse publications as *Christian Century* and *Rolling Stone*. He is a popular professor of Sociology at Georgetown University, as well as an author and radio host. He has written or edited 18 books dealing with subjects such as Malcolm X; Martin Luther King, Jr.; Marvin Gaye; Nas's debut album *Illmatic*; Bill Cosby; Tupac Shakur; and Hurricane Katrina. In his most recent book, *April 4, 1968*, examines how King fought and faced his own death, and what his legacy means.



Named by *Essence* magazine as one of the 50 most inspiring African Americans in the U.S., Dyson is one of the nation's most renowned public intellectuals. Called "a street fighter in a suit and tie," he takes on the toughest and most controversial issues of the day, including race, politics and pop culture, with his fearless and fiery rhetoric.

A native of Detroit, Dyson became an ordained minister at age 19. He later earned a master's and doctorate in religion from Princeton University. Dyson serves on the board of directors of the Common Ground Foundation, a project dedicated to empowering urban youth in the United States. Dyson and his wife, writer and ordained minister Marcia L. Dyson are regular guests and speakers at the Aspen Institute Conferences and Ideas Festival. Together, they lecture on many American college campuses.

Dyson has taught at Chicago Theological Seminary, Brown University, the University of North Carolina at Chapel Hill, Columbia University, DePaul University, and the University of Pennsylvania. His 1994 book *Making Malcolm: The Myth and Meaning of Malcolm X* became a *New York Times* notable book of the year.

Dyson was named by *Ebony* as one of the hundred most influential black Americans. He lives in Washington, D.C. Dyson hosted a radio show on Radio One and has been a commentator on National Public Radio and CNN, and is a regular guest on *Real Time with Bill Maher*. Beginning July 2011, Michael Eric Dyson became a political analyst for MSNBC.

**Bishop Jerome Ross, Sr.** of Triedstone Missionary Baptist Church will receive this year's Dr. Martin Luther King, Jr. Humanitarian Award. CCS teacher **Kenya Davis** will receive the Helen Jenkins Davis Award.

The 38th annual event is Thursday, Jan. 12, 2017, at the Hyatt Regency Columbus. Get your tickets now. The annual dinner is always well attended. Tickets are \$30 per person, or \$240 for a table of eight. Call CEA for yours.

## Are You Retiring?

If you want enhanced severance pay, our contract requires members to notify the district of retirement intentions by Feb. 1 of their retirement year. It is tempting to wait, but we advise that you notify CCS as soon as you have made a decision. It is important that you make the best financial decision for yourself. Early notice helps the district plan more effectively. Advance notice may prevent a colleague from being laid off. It may help the district decide where the greatest classroom needs are. Some members like to wait and see if a buyout is offered. This is not a good strategy. District circumstances change from year to year. Take some time to think about this. Call us if you have questions.



## Know Your Rights

When your administrator pressures you to quickly provide a written or verbal statement about an incident that you witnessed or were involved in, you have the right to call CEA. Do not be insubordinate, but do remind your administrator that you have the right to representation before making any statements.

If you are asked to meet with your principal or supervisor for an unspecified reason, take a moment to step back. It is your right under the law (NLRB v. Weingarten) to:

- Ask the principal or supervisor to clarify the reason for the meeting. Don't refuse to attend, but ask why.
- Get representation. If the meeting becomes disciplinary in nature, you are entitled to call CEA, even if your principal says you shouldn't or can't.
- Have the administrator reschedule the meeting at a time when the representative of your choice can attend. You have the right to the representative of your choice, not your principal's choice. You can be represented by your FR or by a CEA staff member.

CEA suggests representation any time the purpose of the meeting is for one of the following situations:

- Any type of disciplinary action
- Investigation meeting
- Reprimand
- Infraction of a work rule or board policy
- Questions concerning request or use of sick or personal leave
- Allegations of abuse
- Parental, student or community complaint

-  **CEA Fall Election Runoff:** Campaigning for the runoff election for the two Middle School Governor-at-Large positions began on Nov. 17 and will end Dec. 13. Voting began Nov. 29 and ends Dec. 13; votes will be tallied on Dec. 14.
-  **CEA Spring Election:** The following positions will be open in the CEA 2017 Spring Elections: Governors for Districts 1, 4, 5, 10 and Middle School Governor At-Large (three-year terms); 2017 NEA Delegates, 2017 NEA State Delegates At-Large and 2017-2018 OEA Delegates. Members may declare their candidacy from Jan. 4 to Feb. 3. Campaigning begins Jan. 4 and ends Mar. 7. Voting begins Feb. 22 and ends Mar. 7; votes will be tallied Mar. 8. In the event of a spring run-off election, campaigning will begin Mar. 9 and end Apr. 11. Voting begins Mar. 29 and ends Apr. 11; votes will be tallied Apr. 12.
