You Can Vote Now

You can vote early if you can't make it to the polls on November 7. Registered voters in Franklin County began marking their ballots on October 11. Here is the rest of the schedule for the Franklin County Board of Elections: October 11-27—Early in-person weekday voting, 8 a.m. -5 p.m. October. 30- November 3—Early in-person weekday voting, 8 a.m. -7 p.m.

November 4—Saturday in-person voting, 8 a.m. – 4 p.m. November 5—Sunday in-person voting, 1 p.m. – 5 p.m. November 7—General Election Day: Polls are open from 6:30 a.m. 7:30 p.m.

The deadline to request an absentee ballot is noon on November 4. Download an absentee ballot request form at http://bit.ly/2yUH706 and submit it to your county board of elections. Franklin County residents can go to http://bit.ly/2kDE3KP to download a sample ballot. Follow the return instructions carefully and mail your completed ballot back to your county board of elections as early as possible.

Changes to OTES Coming

The Ohio Educator Standards Board (ESB) is appointed by the State Board of Education. The ESB's 18 appointed members include teachers, administrators, higher education employees, a local school board member and a PTA/PTO representative. The work of the ESB is to promote and improve educator quality, professionalism and public accountability on behalf of the students and citizens of Ohio.

At the request of State Superintendent Paolo DeMaria, the ESB began reviewing the Ohio Teacher Evaluation System (OTES) in the fall of 2016. The ESB sought to improve the efficiency and effectiveness of OTES, address the complexities of teaching and learning and focus on educator accountability. The

ESB held a series of public meetings in late 2016 and released a report in January of 2017, containing six recommendations for state legislators to make changes to OTES in state law. The recommendations call for legislators to:

- 1. Update OTES Rubric
- 2. Embed Student Growth into the Revised OTES Rubric
- 3. Remove Shared Attribution
- 4. Embed the Alternative Framework Components as Sources of Evidence in the Revised OTES Rubric
- Structure and Timing of Observations Tailored to Meet the Needs of Teachers in Order to Focus on Improvement and Growth
- 6. Provide a Professional Growth Process for Teachers Rated Accomplished and Skilled

Despite the State Board of Education's approval in April, state legislators failed to include any of the ESB's recommendations in the recent state budget. During the General Assembly's summer recess, ESB members have been working on creating a new OTES rubric. Sen. Peggy Lehner (R-Kettering), who serves as the chair of the Senate Education Committee, has confirmed that she has drafted a bill based on the changes suggested by the ESB. Lehner expects to introduce the bill soon. Keep reading The CEA Voice for updates and opportunities to get involved.

Bargaining 101

Know Your Contract: Class Size

The CCS administration has to make a concerted effort to complete initial class size adjustments within the first 18 student attendance days of the school year. October 1 is the deadline to reorganize classrooms that exceed the class size guidelines prescribed in Article 301 of our CEA Master Agreement. Here are the size limits:

- K-3: no more than 29 students each
- 4–5: no more than 30 students each
- Middle school: no more 35 students per class and 150 students per day
- High school: no more than 36 students per class and 150 students per day
- High school or middle school nonacademic classes must not exceed the number of pupil stations. For instance, assigning 35 students to a computer class with 30 computers would be a violation of the contract.

If at any time class sizes exceed contractual limits, reorganization must take place. If you have any questions about class size, call CEA.

☑ Open Enrollment for your medical benefits will begin Oct. 10 and end Oct. 31. Everyone must reenroll even if you are not making any changes. Look for emails and information mailed to your home from the CCS Employee Benefits Office. Also, see the October 2 Voice for information on how to enroll.

► Have a college senior? Scholarships are available from the CEA Member Scholarship Fund. Each scholarship provides \$1,250 in tuition assistance per awardee. Eligible CEA members must have taught in CCS for the past four years. Your student must have a minimum 2.0 GPA to apply. The deadline to receive the application is 4:30 p.m., Friday, October 20.
