Know Your Contract: Verbal Abuse

Teachers are professionals and should be treated in a



professional manner. Direct verbal criticism of a teacher in front of students or parents reduces the teacher's ability to maintain an orderly teaching environment. Administrators do occasionally need to redirect staff. However, such direction should be respectful and should NOT be given in front of students, parents or other staff members. Section 404.06 of our Master Agreement details your rights when criticism has been lodged inappropriately. If criticism occurs in an inappropriate setting, the teacher may request a conference with the

administrator to discuss the incident. If the administrator repeats this inappropriate behavior, the teacher is entitled to a second meeting and can file a grievance. During these meetings, CEA members are always entitled to CEA representation. Administrators, too, may request Board of Education representation. If you have been subjected to verbal abuse, know that you do not have to put up with it. Call CEA to file a grievance.

Legislation Introduced to Consolidate Education Departments

(As published in the OEA Legislative Watch)

On Wednesday, February 14, 2018, House Bill 512 was introduced. The bill, sponsored by Representative Bill Reineke (R-Tiffin), seeks to consolidate the Ohio Department of Education, the Ohio Department of Higher Education and the Governor's Office of Workforce Transformation into a new, cabinet-level agency, the Ohio Department of Learning and Achievement.

The bill would make no changes to the composition of the State Board of Education. However, most of its functions and policy-making powers would be transferred to the new Department. Under the bill, the State Board would oversee teacher licensure and educator misconduct.

House Bill 512 has seven co-sponsors. The stated goal of the legislation is to align Ohio's education and workforce development departments so the state can more efficiently respond to a changing job market. At a press conference announcing the proposal, Speaker of the House Cliff Rosenberger (R-Clarksville) expressed his support for the bill.

OEA's view: "While OEA agrees with the lawmakers who've offered this proposal about the importance of

preparing our children for a successful future in the workplace," said OEA President Becky Higgins, "we question whether some elements of this proposal are the best way to achieve that goal. In particular, OEA is concerned about the diminished role of the State Board of Education. Members of the Board serve an important function as public officials to whom parents and educators can go to affect K-12 education issues. As this plan makes its way through the legislative process, OEA looks forward to working with lawmakers on the issue."

Article 211: Staff Reductions

The Article 211 process will consist of an "Article 211 Preliminary Roster Lab." It is at the completion of the Roster Lab that building principals learn of their staffing needs. As a result, Administrators may be required to staff-reduce additional least-senior teacher(s) or volunteers to meet their allocation total. The Article 211 Preliminary roster will list all "automatically" staff reduced teachers.

Here are the determinations of Automatically Staff Reduced Teachers:

- Elimination of program or school closure;
- Assignments by Human Resources after completing a two-year placement;
- Job-Fair positions after completing a two-year placement;
- Teachers approved by Human Resources for a Voluntary Staff Reduction.

If a building must staff reduce a teacher, the principal must first ask for volunteers in the area of certification needed for the staff reduction. If no one volunteers, the least senior teacher in the area of certification is staff reduced. Seniority is based upon District seniority not building seniority. The Scholarship application must include the following:

- 1. A statement of the student's personal philosophy and goals.
- 2. Two references: One from a current academic instructor with whom the student has studied during the past year, and one from someone other than a relative.

Applicants must:

- 1. Be graduating high school seniors or students already enrolled in an undergraduate program at a college or
- Have a cumulative point hour of 2.5 or above which must be verified by an official high school or university transcript.
- Be full-time students while enrolled in college.
- Include a copy of the Student Aid Report from FASFA.
- Indicate all financial aid (other than student loans) which they expect to receive.

The Christa McAuliffe Memorial Scholarship is granted each year to a student majoring in education (unless no education applicants apply). This scholarship will be 1½ times the amount of any other scholarships awarded.
