UNCF, the United Negro College Fund, also known as the United Fund, is an American philanthropic organization that provides scholarships for minority students and general scholarship funds for 37 private historically black colleges and universities. UNCF was incorporated on April 25, 1944 by Frederick D. Patterson (then president of what is now Tuskegee University), Mary McLeod Bethune, and others. UNCF is headquartered at 1805 7th Street, NW in Washington, D.C. UNCF supports approximately 65,000 students at over 900 colleges and universities with approximately \$113 million in grants and scholarships. Over 60% of these students are the first in their families to attend college, and 62% have annual family incomes of less than \$25,000.

Though founded to address funding inequities in education resources for African Americans, UNCFadministered scholarships are open to all ethnicities. It provides scholarships to students attending its member colleges as well as to those going elsewhere.

In 1972, the UNCF adopted as its motto the maxim "A mind is a terrible thing to waste." This maxim has become one of the most widely recognized slogans in advertising history. The motto, which has been used in numerous award-winning UNCF ad campaigns, was created by Forest Long, of the Young & Rubicam advertising agency, in partnership with the Ad Council.

### Article 211 Changes

After several conversations with District Administration regarding possible budget reductions, it was agreed that Article 211 needed to be pushed back. CEA told the District we were very concerned about the initial proposed reductions and believed they needed more time to make informed decisions around any budget reductions. Your Association has asked for the least disruption to classrooms and staffing. Because of this, we all agreed more time was needed. As a result, the Priority and Department Round scheduled to

### LPDC Support

The Columbus Local Professional Development Committee (LPDC) will be hosting face-to-face training sessions for becoming a CIMS Facilitator. If you were trained in person last school year, you do not need to attend a face-toface session again this year, and will only need to complete a "refresher" module and the updated Facilitator Agreement (check your email for the links).

For those who are new, CIMS is the district's system for tracking participation in professional development activities, especially with regard to earning CEUs. In order to be a "provider" of professional development and have individuals receive CEUs (e.g., PD Days, BLT sessions, etc.), you MUST attend a face-to-face training to learn all of the important steps to enter PD Activities into CIMS and track attendance.

The LPDC will also be hosting support sessions for those needing assistance in creating an Individual Professional Development Plan (IPDP). All educators with 5-year Professional Licenses in Ohio must have an approved IPDP on file in order to earn credits toward the renewal of that license (for more information about the renewal process of a 5-year license, click here).

## Join RESET

Research Experiences for STEM Educators and Teachers (RESET) provides educators with summer research experience at participating Army Laboratories. The goal of this enriching program is to reinforce teachers' content knowledge through research experience and interactions with Army and Department of Defense scientists and engineers. Selected teachers will participate in on-line learning as a cohort, with a subset of the cohort selected to conduct research on-site with a mentor Army scientist or engineer. At the completion of the program, teachers will be able to translate this knowledge and experience into enhanced science, technology, engineering and math research curricula and enriched learning for their students.

#### Program Milestones:

- April 6th: Teacher Application Period Closes
- April 13th: Selected teachers notified of Level I and Level II cohort status
- April 23rd: Cohort work begins as Level I and Level II cohort members participate in on-line Module 1
- June–July: Level II cohort members participate in on-site research (dates vary by site location)
- August: Level I and Level II cohort members participate in on-line Module 2, Cohort completed

- Article 211: The following school/unit alternative interview panels have been approved: Buckeye MS, Centennial HS, Colerain ES, Columbus Gifted Academy, East Columbus ES, Gifted and Talented, School Counselors, Scottwood ES, Trevitt ES, Woodcrest ES and Woodward Park MS.
- Bargaining Workshop Session 2: School Funding will be held on Wednesday, February 7, 2018. The session will take place at the Columbus Downtown HS and will begin at 4:30 p.m. With talks of the District's impending deficit in five years it is important we understand how school funding works in the Ohio. The Ohio Education Association (OEA) will facilitate this session. All CEA members are welcomed to attend. CEUs will be granted.
- CEA Spring Election: The following positions are open: CEA President; CEA Vice President; Governors in Districts 3 and 6; High School Governor-At-Large (2 positions); 2018 NEA Delegates, 2018 NEA State Delegates At-Large, and 2018–2019 OEA Delegates. Members may declare their candidacy from Jan. 8 to Feb. 9. Campaigning begins Jan. 8 and ends Mar. 13. Voting begins Feb. 28 and ends on Mar. 13; votes will be tallied Mar. 14.
