#### We Must Stand United

Many members have stated that they do not want to engage in politics. Many would prefer that we simply focus on the day to day operations of Columbus City Schools. Unfortunately, politics impacts every aspect of our work. Testing and RIMPS are legislated. How schools are funded, legislated. Our ability to collectively bargain a contract, legislated. But now there is a case currently being heard by the Supreme Court that can destroy our very existence.

You may have already heard about Janus vs AFSCME. It is another attempt similar to Senate Bill 5 to weaken unions, but this time it is by banning the fair share fee. Its end game is a politically-motivated attack to use the Supreme Court to attack Unions.

CEA is the sole representative for all of our collective bargaining matters. CEA is required by law to represent and negotiate on behalf of all of us and all of us receive the same wage increases, benefits and workplace rights that our Association is able to achieve.

A few have chosen not to be a member of the CEA and that is their right. They are, however, required to contribute to the cost of representation, whether through membership dues or a "fair share" fee. Because all of the CCS teachers are entitled to the same benefits, job security, and other protections that CEA negotiates, it's only fair that everyone chip in for the cost of that representation. This is where Janus comes in.

Work Foundation and the other corporations / individuals want to drain unions of funds that have allowed us to make a secure salary, fair and equitable work conditions, retirement securities, health benefits, etc. They are using their massive fortunes to gain outsized influence in politics, chipping away at the progress people in unions have won over the years. Now they want the highest court in the land to take that away from us.

If Janus passes, you are going to be showered with information about why this is "good." IT IS NOT GOOD! The opposition is going to influence your decision through the "golden nugget." What is the golden nugget? The golden nugget is that you will not pay any dues. They will entice you to become a non-member so that you will pay \$0 in dues. That sounds great for all of us doesn't it? If our Association members choose to become non-members, over

time this will begin to erode all the good we have and will negatively impact our Association as follows:

- It will make us more vulnerable to the outside pressures who believe that we do not work very hard, we have "Cadillac" insurance, we make too much money, we get three months off every year, coupled with ~ we have sick and personal leave, etc.
- We will lose our ability to maintain what we have because a Board of Education may feel empowered because CEA no longer has the membership to support/negotiate raises, maintain current health care, 15 annual sick days, and other benefits that currently exist.

If our CEA members begin to choose to be non-members, we become like one of the 27 states that have Right-to-Work laws: Alabama, Arizona, Arkansas, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Michigan, Mississippi, Missouri, Nebraska, Nevada, North Carolina, North Dakota, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, Virginia, Wisconsin, and Wyoming. Most of these states have low salaries, horrible benefits and no due-process. They also make up some of the lowest performing states in the nation.

I ask you to reach out to have a conversation with any of our colleagues who have come from a right-to-work state. Ask them what it is like. Let them tell you their stories. Reach out to your family and friends who are educators in those states and ask about their working conditions, their contractual rights (that's right, they don't have contractual rights).

We are sharing this information with you not to worry you, but to keep you informed on decisions that potentially could directly impact us individually and/or as an Association. I know no one wants to give up what we have fought so hard to gain. The Janus decision will certainly need each of us to stay together as one strong united CEA. We will continue to closely follow this Janus case as it travels through the Supreme Court and keep you updated.

### **Know Your Contract: Paid Holidays**

Section 1501.03 of our contract provides for certain paid holidays throughout the school year, including our six-day Spring Break. However, pay for holidays is not a given. Members who are not in a "paid" status the day immediately preceding the holiday and the day immediately following the holiday will not receive holiday pay. If you are absent and you are not on paid sick leave or personal leave, you will forfeit the pay for those holidays.
