Article 211: Interviews

Interviews for Round 1 of the Article 211 process begin Monday, April 23, and close on Friday, April 27. Here are some tips as you prepare for your interview:

- Dress professionally. You might consider bringing your interview clothes to school and changing prior to your interview.
- Research the schools you are interviewing with. Have an understanding of the schools' focus and programming that is unique to them.
- Be sure you are clear as to the day, time and location of your interview. Interviews for District-wide positions take place at various locations throughout the District so make sure you know exactly when and where your interview will take place.
- Sell yourself. Interviews are one of the few times when you get to tell someone how great you are. Do not be afraid to share all the great things you have accomplished throughout your career.
- If you have questions about the position be sure to ask them before you leave the interview.

Offers for positions can be made starting at 5 p.m. on Friday, April 27, and not before. Please note that a school does not have to give you time to consider their offer. We understand you may have interviewed at several schools and could be waiting to see if you have other offers. However, the schools are also trying to get the best candidates and may choose to move on to the next candidate. If you accept the offer, be sure to sign the Selection Agreement Form. Once you sign the form you have agreed to commit to the school or site for three years.

The primary election is May 8. But you can vote early inperson at your county Board of Elections. In Franklin County, you may vote at the Franklin County Board of Elections, 1700 Morse Rd.

Advance hours are:

- Monday through Friday, from Apr. 16-27: 8 a.m. 5 p.m.
- Monday, Apr. 30, through Friday, May 4: 8 a.m. 7 p.m.
- Saturday, May 5: 8 a.m. 4 p.m.
- Sunday, May 6: 1 p.m. 5 p.m.
- Monday, May 7: 8 a.m. 2 p.m.

Know Your Contract: Direct Verbal Criticism

Your Association knows that direct verbal criticism of a teacher by an administrator in front of students or parents tends to reduce a teacher's effectiveness in maintaining an orderly teaching environment. Article 404.06 of the *Master Agreement* specifies that this practice should be avoided and provides a remedy for bargaining unit members, should this criticism occur.

If you believe your administrator has subjected you to direct verbal criticism in front of students or parents, it is your right to request a conference with an administrator to discuss the incident. You have the right to be accompanied and represented by a representative of the Association.

Following the initial conference, if your administrator has subjected you to direct verbal criticism a second time, it is your right to request a second meeting with the administrator and a representative of the Superintendent and to be accompanied and represented by a representative of the Association. You Are Not Alone: EAP is Here

From time to time we all feel stressed out. We have a tough job and personal problems on top of everyday challenges can make even the strongest among us feel alone sometimes. Luckily, one of your negotiated benefits is the Employee Assistance Program, also known as EAP. It is a way for you to obtain help with no cost to you for confidential and private counseling services. The program is run by ComPsych, which provides supportive resources via phone and website.

When you call 800-774-6420, you can get a referral for matters related to work, family, health and other areas of your life. Referrals include free, short-term counseling for stress, depression, grief, substance abuse, family and caregiving consultation, legal and financial issues, household matters and personal and family safety. It is a good idea to consider counseling if you:

- Feel overly preoccupied with a problem
- Fail repeatedly to solve it by yourself

- Find yourself denying that a problem exists or hoping it will go away
- Feel that you don't have the resources to solve it
- Feel unhappy most of the time
- Experience problems with family or friends because of it or get tired or sick from it.
