

May is Better Hearing and Speech Month



Each May, Better Hearing & Speech Month (BHSM) provides an opportunity to raise awareness about communication disorders and the role of American Speech and Hearing professionals in providing life-altering treatment.

The following are suggested activities to raise awareness about communication disorders and the services provided by our speech and language therapists, pathologists and audiologists:

- 1. Discuss effective communication with students. Ask students what words come to mind when they think of communication.
- 2. Be creative. Give kids an art assignment, such as illustrating why communication is important or what communication means to them. These can also be posted in the classroom, cafeteria, or a display case in the school. Other ideas include writing a song about communication and holding a communication-themed scavenger hunt.
- 3. Distribute and display materials. Send a letter home to parents about recognizing the early signs of communication disorders.
- 4. Educate your colleagues. Put materials (with goodies) in teacher, administrator, and school counselor mailboxes to tell them more about your services. It is often helpful to talk with teachers about voice issues teachers sometimes develop, giving them ideas regarding good vocal hygiene.
- 5. Partner with the high school career/school counselor. Spotlight speech-language pathology and audiology as potential career paths.

Memorial Day is a Paid Holiday



Section 1501.03 of our contract provides for certain paid holidays throughout the school year, including Memorial Day. However, pay for holidays is not a given. Members who are not in a "paid" status the day immediately preceding Memorial Day and the day immediately following Memorial Day will not receive holiday pay. If you are absent and you are not on paid sick leave or personal leave, you will forfeit the pay for this paid holiday.

Had a qualifying event?

A change in your life or job circumstances can make you eligible for mid-year changes to your health benefits. Examples of qualifying events include marriage, divorce, legal separation, birth or adoption of a child and loss of coverage in your spouse's coverage. Let the Benefits Team at (614) 365-6475 know if you have such qualifying circumstances. The changes must be made within 30 days of the qualifying event.

Pay Plan Change for 2018-2019

To be eligible for participation in year-round "stretch pay", employees must meet the following requirements:

- Regular assigned school-year employee
- Scheduled to work 20 or more hours per week

Employees that meet these requirements have the option to choose:

- Twenty-one (21) pays: September June
- Twenty-six (26) pays "stretch pay": September August

The plan remains in effect until the employee makes a change during open enrollment next year. If you are already on "stretch pay", you DO NOT need to complete another form unless you want to change to 21 pays per year.

OPEN ENROLLMENT DATES:

Certificated employees: May 1 – August 17, 2018 (Form due in Payroll by 5:00 p.m., August 17, 2018)

Forms received after the due dates will not be processed.Changes MAY NOT be made outside of the open

enrollment period. Pay Plan Change Forms are available on the Employee Self Service system under Resources and in the Payroll office.

Still Looking for Mentors

Are you interested in mentoring a university student next school year (student teacher, observation student, OSU FEEP student, field placements, etc.)? Would you like to earn CEUs for doing so? Have you been employed as a CCS Teacher/Licensed Support Personnel for at least three school years? If so, please complete the online application using the link below.

All CCS Teachers and Licensed Support Personnel who would like to mentor a university student during the 2018-19 school year must complete the online application. Upon completion of the online application, the building principal/evaluator will receive a copy and will then have the opportunity to approve or reject the application. If your application is approved, you will then go into the pool to be matched with university students. When completing the application, be sure to indicate the anticipated school(s) or department (Nurses, Psychologists, etc.) in which you will be working next year.

Upon being matched, you will receive an email notification with all of the details. You will then have the opportunity to accept or reject the match. If you accept, the university will be informed and they will contact you directly. If you reject the match, you will go back into the pool. The building principal/evaluator will receive copies of the potential match information as well as your response (accept or reject).

CCS Teachers and Licensed Support Personnel mentoring university students now have a wide range of opportunities to earn CEUs. CEU credits for mentoring university students range from . 5 CEUs to 3.0 CEUs depending on the type and length of placement.
