Check Your Check

Your Association has created the CEA Teacher and Licensed Support Professional Evaluation System Checklist. This evaluation form is for members to use to record all activities of the evaluation process. The form will help you keep track of pre-observation conferences, observations, walkthroughs and final conferences.

We must be vigilant about making sure everyone follows the guidelines for ILEAD. We know from experience that if we track the events that occur during the evaluation process, we can get a good idea of where we stand. This document is not an official CCS form. It is merely a tool for members' personal use in keeping track of your progress.
