Know the Contract: Classroom Atmosphere

Achieving school climate goals is a partnership between teachers and administration. Section 208.01 of the *Master Agreement* clarifies that partnership, particularly with respect to the administrator's role.

Building administrators have a responsibility to support teachers in their efforts to maintain control and discipline in their classrooms. This means administering the school and district discipline policies and backing teachers when issues arise. Teachers must know the policies as well and rely on them. But they are not alone in this responsibility. It's a two-way street.

Your Association has heard our members' concerns regarding the administration of discipline in many schools. If you believe you are not receiving the appropriate amount of administrative support and assistance with respect to the maintenance of control and discipline in your classroom:

- Request a copy of your school's discipline plan from your administrator to ensure that they are following the discipline procedures for the school.
- Keep documentation, including discipline referrals you have written during the school year to verify the amount of administrative support and assistance you are receiving.
- Submit discipline-related concerns to be addressed at your school's next ABC meeting. Plan to attend with all of your colleagues.
- Speak with your administrator personally about your discipline-related concerns. Make sure you reference Article 208.01 of the *Master Agreement*. Send them a follow-up email after the meeting, thanking them for their time and summarizing what was discussed. End the email with "If any of this constitutes a misunderstanding on my part, please let me know."

Your Association knows that with all the demands put upon us as educators, we barely have time to use the restroom or eat lunch during the workday—to say nothing about creating a documentation trail just to ensure that someone else is doing their job so that you can do yours.

We know that often times many issues, including support with regards to discipline can be worked out informally at the building level. However, if you are unable to informally resolve the discipline problem at the building level, this documentation trail is critical in assisting your Association in advocating on your behalf, which may include filing a grievance to ensure that Article 208.01 is followed at your school.

Your Association is asking for FRs to immediately send a copy of their school's discipline plans to Vice President Phil Hayes at the CEA Office and their District Governor. Additionally, FRs should plan to bring a copy of their school discipline plan to their CEA District Meeting on Thursday, Oct. 18. In the coming issues of *The CEA Voice* we will list all of the schools who have their discipline plans on file with CEA.

That the Board provide a sufficient number of elementary physical education teacher(s) to ensure physical education once per week in grades K–5 for 45 minutes and that NO REPRISALS be taken against the grievant or any other bargaining unit member due to the filing of this grievance.	Based on the above, no violation of the contract occurred; however, management in the Unified Arts Department will continue to provide needed support to the substitute currently in place and ensure that a permanent position is filled as soon as the new FTE is approved.
