Dear Brothers and Sisters:

In 2014, Ohio instituted new graduation requirements for high school students, effective for the class of 2018. Three pathways were specified; earning 18 points on end-of-course tests, score "remediation-free" on either the ACT or SAT or earn a State Board of Education approved industry credential.

Over the course of the past four years, Ohio's statewide tests have changed from PARCC to AIR; the work that our bargaining unit members have engaged in to prepare our students to meet the new graduation requirements have changed as well. In the 2016–2017 school year, educators, students and their families were concerned that the multiple assessment changes and new graduation requirements would leave many of the class of 2018 behind.

Estimates forecasted that more than 20 percent of the statewide class of 2018 would not meet the new requirements and would not graduate. After intensive lobbying, the Ohio General Assembly passed a bill that provided a temporary fix, adding two additional pathways for graduation. However, these two options were only made available to the class of 2018.

The problem that faced the class of 2018 still faces the class of 2019. Currently, it is estimated that statewide more than 20 percent of this year's senior class still need additional intervention and support in order to graduate. The class of 2019 shouldn't be caught in the lurch because the state keeps changing things—it's a lot like Lucy pulling the football away from Charlie Brown at the last minute.

Interim Superintendent Dr. John Stanford and I are members of the Ohio 8 Coalition, which is made up of the superintendents and union presidents from Ohio's eight largest urban districts. We are all deeply concerned about the graduation crisis that the class of 2019 is facing without intervention from the Ohio General Assembly.

On Thursday, Oct. 11, the CEA Board of Governors unanimously passed a resolution calling for the Ohio General Assembly to act immediately and extend the two additional pathways to the classes of 2019, 2020 and 2021. On Tuesday, Oct. 16, I stood in front of the Board of Education with Interim Supt. Dr. Stanford in Solidarity as we both called on the Board to pass their own resolution in support of the extension of the two additional pathways.

The Ohio General Assembly must not only extend the two additional pathways, but also develop an equitable, realistic and long-term solution to fix the graduation pathway issue. Our students deserve as much. As your Association President, I am asking you to contact your state legislator and demand that the two additional pathways be extended for the classes of 2019, 2020 and 2021.

Discipline Plan Update

The CEA Master Agreement specifies that your administrator, in consultation with the ABC, must create a discipline plan and put it in writing. The discipline plan establishes procedures for the administration of all forms of discipline within the school, including procedures related to suspension and recommendation for discipline.

At schools where the principal is newly assigned, the discipline plan must be in place within ten days following the first day of student attendance. A school that has the same administrator from the previous year must have a discipline plan in place by the first day of student attendance. Failure to have a plan in place is subject to a grievance at Step 2 against the principal.

Got a great idea?

It can be hard to be innovative in the classroom, especially with a multitude of testing and state mandates. However, we encourage teachers to keep exploring new and exciting ways to engage our students. That's what the Reform Panel is designed to do.

When you come up with an idea, the panel can grant you a variance to try something new. Article 1503 of the contract details the process. The panel consists of representatives from CEA and the administration. It's simple: Begin by making a suggestion to your ABC. The Senior Faculty Representative conducts a building vote, then refers it to the Reform Panel with signatures from both the principal and Senior FR.

Create a cadre of staff members and parents to seek new and innovative programs that would benefit your students. Do your research and make a proposal. The Reform Panel will also help you define potential problems and recommend further steps.

CEA believes that the best decisions about teaching and learning are made at the building level by the people who work there. Successful districts have moved from centralizing operations and support to building-level support.

We have a tool: the Reform Panel. We need to use it.

To exercise this option, you must submit the notice of retirement by Friday, Nov. 2, to Human Resources.
