

## **Bargaining Update**

Your Association thanks the nearly 900 members who submitted more than 2,000 items for negotiations at the two Town Hall meetings and the Bargaining Issues Survey. The CEA Bargaining Team has begun the process of classifying the items submitted by members. Submitted items that are currently in the contract, contrary to state/federal law, work of another bargaining unit or were duplicates of other items will not be included in the survey. Additionally, submitted items that asked CEA to maintain currently contractual provisions will be excluded; your Association's intent is to improve, not just maintain our current Master Agreement. Items that were submitted that can be addressed through existing joint Association/Administration efforts will be referred to the appropriate personnel. The Bargaining Team will be working through the month of November to fit the submitted issues into the CEA Bargaining Priorities Survey. It will be sent to all members' personal email addresses on file with CEA on Friday, Nov. 30, at 4:30 p.m.

# **Know Your Contract: Classroom Visitors and Parent Conferences**

We know the possibilities are endless when our students' families and caregivers visit our schools. It's important to maximize their involvement in their children's educations. Unfortunately, in today's high-stakes world of education, visitors can disrupt the learning process in our classroom. The Master Agreement provides you rights regarding visitation to your classroom in Article 207. Note the following: All visitors to a school must check in at the office.

- If you are expecting a visitor, you should be advised by the office that he or she has arrived and is on the way.
- If you are not expecting a visitor, he or she should be escorted to your classroom.
- You have the right to reschedule a visitor when prior arrangements have not been made.
- No electronic devices will be used to make a record of the visit or conference except by agreement of the teacher.

For more information on visitation to your classroom, reference Article 207 of the *Master Agreement*. If you are experiencing issues with classroom visitation, please speak with your Senior FR or call the CEA office at (614)253-4731.

## **Discipline Plan Update**

The *CEA Master Agreement* specifies that your administrator, in consultation with the ABC, must create a discipline plan and put it in writing. Failure to have a plan in place is subject to a grievance at Step 2 against the principal.
