

## NEAMB Insurance Carrier Affiliate has Changed

There have been some requests for an update on NEAMB's affiliation with California Casualty Insurance.

California Casualty was the NEA Member Benefits chosen insurance carrier affiliate. California Casualty made a business decision to retract their coverage areas to a few states and end insurance offerings in all others. The Ohio program is set to end in late 2024 to early 2025. Members who have California Casualty insurance will be notified prior to renewal dates that their policy cannot be renewed. There are no new policies being written by California Casualty for Ohio. NEAMB has found a replacement affiliate carrier which is Travelers Insurance. If a member is a current California Casualty customer, there is transition information at https://bit.ly/4605kbS.

Have your college ID number available when applying. You will automatically be sent a confirmation email once your application is submitted. Documentation is required with each fee waiver process. Your priority status will change without the proper documentation.
