Our New Contract Language at Work: District Pays for Outsourcing CEA Jobs In Nov. 2023, CEA Social Worker SFR Jennifer Davis

was reading the CCS Board of Education minutes when something raised a red flag: more than \$800,000 spent on 21 positions from the organization "Communities in Schools" which looked an awful lot like the outsourcing of social worker and counselor bargaining unit work. She contacted the CEA office to inquire about whether the Union was notified and engaged ahead of the potential

ing contract language. No such notification or meeting had occurred. CEA filed a Step Two grievance. It was predictably denied, and we appealed to arbitration.

Before an arbitration hearing was scheduled, the District approached us about a settlement. The results of those discussions is a grievance settlement agreement which was reached at the end of January. The District will be writing a check to CEA in the amount of \$15,500 for the annual dues of what should have been 21 CEA bargaining unit members. There has been no decision yet on what to do with this money, but all of the discussion is focused on something that directly benefits our CEA social workers and counselors.

This is a big, big win. It should cost the District to outsource our work, and thanks to our new contract language and member enforcement efforts, it does. Most importantly, this is an incentive to follow our language and come to the Union first, as required, so that we can keep CEA work in-house, with the District employees who know our students and families best.

TOSAs Under A Three-Year Commitment Eligible to Interview

Recently, your Union signed a Letter of Agreement with the District that will allow Teachers on Special Assignment (TO-SAs) who are under a three-year commitment to participate in Article 211. TOSAs who are currently under a three-year commitment may interview in Round 1 or Round 2 of 211 for any position for which they currently hold the appropriate license or certification. Since these TOSAs are not staff-reduced, they will be ineligible for Job Fair.
