#### Trash the Trackers

Your Union has been made aware of a variety of electronic "forms" that our members are being strongly suggested to use. They include, but are not limited to TBT Trackers, data collection forms, and a variety of other forms.

During your TBT, you should be keeping minutes. There is no requirement to use a specific form to keep these minutes, except that the final product should be in an electronic format. There are a variety of resources available if you would like to utilize them—if you don't want to use them then you don't have to.

Section 108.03 of the Master Agreement states, "All Administrative forms provided by this Agreement shall be mutually acceptable to the Board and Association." Section 206.01 also says "The Board recognizes that clerical responsibilities detract from the effectiveness of the classroom teachers; therefore, a continued effort shall be made, with this Agreement, to avoid substantive increases in such clerical work." To date, the administration has not engaged in any discussions with your Union about any additional administrative forms required of our members.

If your administrator asks, requests, intimates, suggests strongly, or even begs you to use a home-grown provided form, simply send them an email from your school account. In that email, ask your administrator one simple question—Are you directing me to use this form as a term and condition of my employment? Their answer should be a simple no, that they are simply offering a resource for you to use if you choose to do so. If the answer comes back yes, please contact the CEA Office.

## **Grievance Update**

CEA works to protect your rights and maintain the integrity of the negotiated contract. While we advise bargaining unit members to work out problems at the building level first, we know this isn't always possible. We regularly inform you of grievances we are working to resolve. ## **Workspace/Learning Space Equity Audit**

One of the Memorandum of Understandings (MOU) won in the 2025–2028 *Master Agreement* includes a workspace/learning space audit. The audit will allow CEA to collect information from members regarding the type of spaces they have to complete their work with students, parents, and colleagues. A flyer with a Survey Monkey link was given to Faculty Representatives at the CEA Legislative Assembly on Sept. 11. Each unit's ABC should work together to collect the information requested in the survey no later than Nov. 2, 2025.

Once that information has been compiled, CEA will present a report to the Article 108.02 Joint Labor-Management Committee, CCS Board of Education as well as returning the information to our units. The language also states that CEA will present the report to any board committee that is considering building realignment, consolidation and/or closure and program allocations. The contract language also states that this report will be a topic of discussion for our next successor agreement. Please make sure that your unit's ABC is working to complete this survey by Nov. 2, 2025. ## Open Enrollment — It's Required

During Open Enrollment (Ends Oct. 24), all benefits-eligible bargaining unit members must do one of the following:

- 1. Reconfirm any current benefit elections.
- 2. Elect or make changes to benefits (add or delete dependents, update beneficiary information, etc.)
- 3. Waive coverage Employee Self Service (ESS) will be used for the 2026 enrollment process. Make sure you are able to log on to ESS PRIOR to the start of Open Enrollment. Benefit choices made during Open Enrollment will be effective Jan. 1, 2026. This year's Open Enrollment is completely virtual.

#### To participate in Open Enrollment, benefits-eligible bargaining unit members can:

- 1. Log into ESS to make your elections for core benefits (Medical, Dental, Vision, FSA, and Life), you do not need a counselor.
- 2. If you do need support with making your elections through ESS, meet online with a Benefits Counselor in a cobrowsing session for both core and voluntary benefits. Visit <a href="https://columbuscityschools.annualenrollment.net">https://columbuscityschools.annualenrollment.net</a> to schedule your call center enrollment meeting ahead of time, or call (614) 401-5172 from 9 a.m.-7 p.m. At your scheduled appointment time, you will receive a call from the iBTR Enrollment Representative. The phone number they will be calling from is (614) 401-5172. You are encouraged to save the number in your phone so you will know who is calling.
- 3. Use ESS to confirm, change or waive your benefit elections. CCS must report health care coverage information for its employees and their dependents to the federal government. Verify that the Social Security numbers entered into ESS for you and your dependents are correct. Note that if you are enrolling a new dependent, you will need to verify their eligibility. Please be on the lookout for communication from BMI, the District's dependent verification administrator.
- 4. Remember that if you enroll in Core benefits through ESS but also want to make changes to your voluntary benefits, you can make those changes yourself on the bswift platform by visiting **columbuscityschools.bswift.com**. You can watch a video to learn to use bswift by copying and pasting this link in your browser: <a href="https://youtu.be/IM1ZYwVsygA">https://youtu.be/IM1ZYwVsygA</a>. If you need assistance with your voluntary benefits, you can reach out to iBTR by calling (614) 401-5172. Voluntary benefits include: Short-Term Disability, Long-Term Disability, Critical Illness Insurance, Accident Insurance, Hospital Insurance, Pet Insurance, Identity Theft Protection, Whole Life, and Term Life Insurance.

## **Retiring? Avoid OTES**

Bargaining unit members who are planning on retiring during the 2025–2026 school year can be exempted from the Ohio Teacher Evaluation System. To take advantage of this, submit your notice of retirement to Human Resources by Friday, Oct. 31. You must continue to complete the evaluation process until your retirement has been approved by the Board of Education.
